The charity was set up in 1973 to help primary school children with the eading. One hundred children in Portsmouth are now receiving a volunteer's special help and encouragement with the eading on an individual basis for one hour a week.

Changes To The Constitution

In Previous years the Forum has been able to fund the printing of MILTON MATTERS through successful applications to the Community Initiatives Scheme run by PCC. As a result of changes to this scheme we are in a situation where we need to be able to generate our own funds - to this effect we have to seek approval from the Forum to amend our constitution. The following section is therefore proposed for inclusion.

"The Forum shall have the power to raise funds on behalf of the Neighbourhood Forum for the purpose of funding Milton Matters and other projects agreed by the Forum.

An account shall be opened in the name of the Forum with a reputable "High Street" institution and the Forum shall authorise the Chair, Vice Chair, Secretary or designated Committee Members to sign cheques on behalf of the Forum.

All cheques shall be signed by not less than 2 authorised signatories.

At the annual general meeting the Secretary shall produce in writing a full account of all financial transactions in accordance with the requirements of the Charities Act."

The Planning Department can decide the merit of tree protection in conservation areas to maintain the character of that area.

The Planning Department prefers early involvement in site re-developments to select the best trees to be maintained and ensure the design of the development takes these trees into consideration including protection during the build. A land survey grades trees into categories:-

Green for most desirable, blue for groups, brown for minimal lopping and red for removal.

If a TPO is breached in any way the penalties are high.

Members of the forum called for more voluntary tree wardens and a plan of TPO's to be held in Milton Library.

MILLENNIUM EVENTS IN MILTON PARK

The Chair introduced Colin Read PCC Parks Services Manager.

The 75th Anniversary in Milton Park was a huge success but members views of this years funfair were less favourable.

Mr. Read explained plans for a Millennium Parks Road Show to be staged in six parks at two week intervals.

He asked for commitment and ideas to support a one day event.

Ideas already put forward:-

- * A stage for local bands
- * Marquees for community organisations.
- * Sports development for children
- * Funfair for small children
- * Catering by a funfair provider who will provide some funding.
- * Portsmouth Players to open the Barn
- Local Pubs already interested.

The cost was explained and the idea of a one day event to maximise the impact with a full and interested programme was supported by the Forum with an offer of help in arranging the event.

The Chair thanked Mr. Read and explained a funding bid had been submitted to the Community Initiative Fund.

MOBILITY POLICY - PORTSMOUTH UNIVERSITY

The Chair welcomed Patrick Finch the Director of Estates and resources for Portsmouth University for coming to discuss the Enforcement of Parking Restrictions at Langstone Campus, Furze Lane which in the opinion of local residents was clearly not working. Mr. Finch explained the background to the 1993 Mobility Policy aimed at reducing the impact of the University on the City.

Specific Issues

Restrict movement of cars between sites Minibus service provided

network of cycle provisions, working with the City

Managing the University car parks effectively, 1500 spaces available.

Expansion of the I.T. network facilities to all sites to cut out journeys eg Library.

New Introductions

University car parks have a stricter regime using permits A charge for students and staff which has produced, £35,000 this year and should be £55.000 next year.

Discouraging the use of cars, by indicating alternative transport services.

Fewer parking permits in the University parking areas.

1000 cycle racks installed around the City some belonging to the University.

Free Minibus transport between sites

Discussions with 'First Bus' to improve late night service for students.

Student Union Representatives educating the Students.

With regard to the Langstone Campus, the no student parking policy was not working and could not be enforced. Residents were invited to telephone 834418 with specific complaints e.g. parking in disabled spaces.

The Forum considers the Mobility Policy ineffective and lacks confidence in actions being taken. Mr Finch was asked to re-examine the problems and consider alternative proposals.

Other issues raised:-

- Why are University Car Parks not fully utilised? It is part of discourage car usage by restricting parking permits.
 It was suggested filling available spaces would relieve pressure in the city.
 - Enlarged Sports facilities at Langstone will be met by more buses to transport players but more on road parking cannot

be ruled out.

- Wheel clamping if circumstances dictate.
- Local resident to be allowed to park on Campus this idea could be looked at.
- Residents only parking scheme. The Forum did not support this idea at present.

The Chair thanked Mr Finch but confirmed the Forums view that the policy is not working or enforceable and looked forward to any new proposals from the University.

Mr Finch agreed and would discuss the issues again and try to improve the situation.

ANY OTHER BUSINESS

Play Areas at Milton - St James Housing Area - PCC awaiting handover of site.

Play Area - Milton Common - Proposals in early stages. The Forum voted 17 for none against.

Amendment to Forum Constitution to include holding a bank account. Post of Secretary for next two years.

The Chair thanked all of the speakers.

It can be reserved by local clubs and groups for football, lacrosse or hockey by phoning **843520**. The pitch offers car parking on the Campus, not local roads please, and changing facilities.

THE CHAIR'S OPENING ADDRESS

TREE PRESERVATION ORDERS

The Chair welcomed Bob Colley from PCC Planning Department and Stewart Campbell Portsmouth City Assistant Tree Officer.

Milton has 1900 of the City's 5500 trees with many concentrated in the St. James Hospital and Locksway Road University sites.

The 1990 Act gave Local Authorities the power to protect trees with a Tree Preservation Order (TPO) and the regulations were explained.

The order covers trees within an area, particular specimens or groups of trees.
