

'THE BREWERS ARMS'

There are some excellent pubs of all types in the Milton area, but it would be hard to find a more traditional one than

The Brewers Arms on the Milton Road.

Since the much-loved landlord Harry left, the pub was seriously lacking in t.l.c. However, George Gale & Company, owners of the property, asked Patsy and Richard Parker, highly experienced landlords within their tenanted group, to hold the pub on their behalf.

Not wishing to leave their seafront home in Bognor Regis for very long, Patsy and Richard had not intended to stay at the Brewers, but Milton and its people worked their magic on them and they are now pleased to be permanent fixtures in the pub which is going from strength to strength.

As well as fine local wine and real ales, the pub has Sky Sports and Sky Premiership. Harry's bar at the rear of the property is now available for hire for small parties and business meetings, but is always open to everyone on match days.

If you have never been in The Brewers Arms or have not been in there for some time, there will never be a better time to try it than at the special events the new management is putting on. For example, on Sunday afternoon, 12 September, a party and Bar-B-Q with live music from the great local band the Racketeers was an example of what the pub can offer you. Watch out for details of future events.

Dymond Building Builder Is Found

"I never thought that I would outlive the Dymond Building"

Bill Long was born in 1920 and lived in Brompton Road, Southsea. At the Reginald Road school he was good at 'manuals' which included metalwork and woodwork. He recalls visiting hobby exhibitions held at the Guildhall where schoolboys used to demonstrate their skills.

He left school at 14 and his father, who worked for Frank Privett, Builder, had his son indentured with the company. The document, which Bill still has today, made clear all parties' commitment to the legal framework of an apprenticeship. The builder undertook to pay his apprentice 5 shillings (25 pence) per week in his first year, rising to £1 per week in his sixth and final year. The company would instruct him in carpentry and joinery whilst his father had to sign the contract agreeing to provide sufficient meat, drink, clothes, washing and mending thereof, lodging and other necessaries throughout the entire length of the apprenticeship.

Bill Long recalls working 44 hours from Monday to Saturday and even working on Good Fridays. Frank Privett, the first Lord Mayor of Portsmouth in 1927, was a strict employer forbidding smoking at work and tea drinking on the job. Bill recalls that when he and the workmen were melting block glue in their glue kettles, they would sneak a 'brew' and squat down behind the benches to get an illicit cup

of tea at work!

Bill remembers working on the construction of the Dymond Building at the Portsmouth Council's College of Education at the end of Locksway Road in 1937. The piece of skirting board discovered during the recent demolition, and mentioned in the last *Milton Matters*, listed his name on the back, with that of M Hodge, L Pharoah and F Tong, and the date as 3 August 1938. Bill remembers Mr Hodge who was also a carpenter and Mr Pharoah who was a labourer. Mr Williams was the bricklayer on the same job and when the superstructure was complete, left to work on Boathouse 4 in the Dockyard, leaving Bill in charge of the Dymond Building. When Bill saw the long-lost piece of skirting board again, he recalled the finest materials had been used for the building - oak panelling for the Assembly Hall provided by a company from Darlington. The man who came down to Portsmouth to measure and pre-fabricate the panelling worked on the job at night. The summer of 1938 was so warm, he spent the days on Southsea beach! Bill believed that a local company in Copnor Road, Marchetti's experts in terrazzo and mosaics, provided the flooring and staircases. The work was finished by 1939; by then Bill had married his wife Doris.

As soon as bombing began in Portsmouth in World War Two, a squad was formed by Privetts to move around the city, making bombed buildings safe for people to be able to continue to live in them. Bill headed this team. He then moved on to work for Portsmouth Aviation and Airspeed making aeroplanes such as the Oxford, from plywood and spruce. Bill moved to Cheltenham to advise them on the quality and construction of wooden framed aircraft used for training RAF crews due to the shortage of metal during the War.

Doris worked for the United States forces nearby and remembered when the US troops had been eagerly awaiting the arrival of US Women's Armed Forces who were being shipped over to the United Kingdom to join them. The troops went to watch the parade of re-inforcements preceded by bands and led by a drum major. The men's spirits flagged when they discovered the new recruits were huge women with blotchy complexions whom the men complained had loud strident voices. They much preferred the British girls with their lovely skin and neat figures! Possibly due to rationing!

Bill lives near Court Lane School and, at 84 years of age, still takes a great interest in construction and the construction industry. It was a delight to meet Bill and Doris Long, to hear their recollections of how different life was in Portsmouth in 1938 and Milton Matters wishes them all the very best and thanks them for their time.

'On The Beat'

Hampshire Constabulary has recently launched the 'Safer Communities' campaign. Under the banner of 'Safer Streets', strategies have been developed which focus on the Constabulary's handling of reassurance issues: violent crime (with a particular focus on serious sexual offences and domestic violence); drugs, anti-social behaviour and tackling the terrorist threat.

With the support of local residents, the police and Portsmouth City Council have successfully applied for the area at the eastern end of Milton to be classed as a designated area as defined by Part 4 of the Anti-Social Behaviour Act 2003 - a detailed map of the area can be obtained from the Beat Office at the address below. This came into effect on 1 June 2004 and is set to run until 30 November 2004.

At the time of writing, Community Beat Officers from Southsea Police have made two arrests in accordance with the new legislation—the first and only arrests to date within the City of Portsmouth. One of the persons arrested received a conviction at Court, and the other was given a police reprimand. You will be reassured to know that Hampshire and the Isle of Wight are among the safest places in the country to live, work and visit. Over the past ten years, the number of domestic burglaries in the two counties has halved and the number of thefts of and from vehicles has fallen by over 45 per cent.

The 'Creating Safer Communities' programme will be the focus of Hampshire Constabulary's operational activities over the next twelve

months. The programme is made up of four campaigns:

Safer Homes, which targets domestic burglary;

◆ Safer Vehicles, which aims to drive down vehicle crime even further;

 Safer Streets, which will tackle violent crime, drugs, disorder and the terrorist threat; and

 Safer Roads which will help the police to reduce the number of deaths and injuries on our roads.

UPDATE ON LOCAL ISSUES

Skateboarding facilities in Milton & Bransbury Parks

The Council is making progress re planning and insurance.

New City Plan

Portsmouth City Council is incorporating some recommendations into the City Plan. This should be in local libraries in July.

New housing development

The Neighbourhood Forum took up the question of road names in St. James, but the Hospital's suggested names have been accepted. The Forum is trying to persuade Barratts to consider new names for the 'West Point' development on the old Milton campus site.

Traffic

Vernon Avenue residents are concerned about proposals to change the access to the traffic lights at Rodney Road/Velder Avenue. No changes are proposed to the layout at present.

Police Action Zone

The Police Action Zone took effect from 1 June 2004 and covers the eastern side of the Milton Ward.

Children under 16 can, if necessary, be removed to their home address after 9 p.m.

Residents' parking

A 'spoof ' letter – somewhat alarmist – is going round the area regarding residents' parking. There is no official survey being carried out at present. In July there will be a survey in central Southsea, there are no plans for Milton at present.

Portsmouth University

Student car parking near Halls of Residence is a problem. A student representative may be invited to meet Milton Neighbourhood Forum.

PLANNING APPLICATIONS

John Slater (Portsmouth City Council) explained likely areas of residents' involvement with planning applications and plan making.

Representatives from Hedley Greentree Partnership explained the proposals for the Fratton Park development and the benefits for the club of staying in the city. Increasing the existing South Stand would adversely impact on Alverstone Road The stadium capacity will be increased in two stages to 35,000, funded by the supporting residential development of 536 apartments in eight buildings, the highest being 17 storeys. There will be 750 car parking spaces.

Forum Minutes - Continued

BENEFICIAL SCHOOL

There is a draft Planning Brief for the East Shore School on Eastern Road. The site is 1.5 hectares (1.5 football pitches) and will be released by the move of East Shore and Futcher Schools in 2006 to a new school on Milton campus.

Major issues in developing the site are the views of local people, prevention of crime, lack of a local convenience store and doctors' surgery, Eastern Road pedestrian crossing, trees to be retained. Constraints to the development are the amenities to the rear and a sewer under the centre of the site. Housing is the proposed use, with possibly a surgery or shop. Mixed use for this site was not mentioned. Keeping traffic moving along Eastern Road needs to be taken into account together with noise levels. A minimum of 45 new housing units on the site is suggested. Copies of the planning brief will be in local libraries and on the Portsmouth City Council website for comment by 5 July 2004.

PRIMARY CARE TRUST

Judy Hillier gave an update on plans for St James Hospital, with 'Oakdene' (a 14-bed unit), replacing a St James ward with the same type of patients. They will have single sex rooms, giving privacy to support recovery and will move in during June. A new 26-bed unit, 'The Orchards', will replace Foxleigh and Solent Wards and will include occupational therapy facilities. This is planned to open on 12 October 2004.

Other than above, there are currently no plans for new buildings on the St James site.

The 'Woodlands' building is being converted for hospital consultants and administration staff. The space released should then be available for intermediate care services or chronic disease management (i.e. to keep patients out of hospital).

There had been concerns by local residents about security on the St James Hospital site, with reports that the police were frequently being called out to the hospital. Judy Hillier explained that this might be for reasons other than connected with the hospital or patients, e.g. local youths on the site. An external security firm has been contracted to patrol the site. It was noted that the hospital social club had become a local facility rather than being restricted to use by hospital staff.

Local residents also noted that there was a 15-foot high security fence around the 'Oakdene' unit. This is to be screened by plants.

St James Hospital is being converted to an Intermediate and Community Care Hospital, so there will be a gradual change of services undertaken there so that it is not exclusively for mental health.
