What Does Your Committee Do?

Your Forum Representatives attend regular monthly Committee meetings to which Milton councillors are invited, to discuss issues which have been brought to their notice by residents or the Council. They also keep a watch on local planning issues and do their best to notify residents of major schemes occurring between Forum Public meeting dates. Since the last Forum they have:

Arranged 2 open evenings on works to Milton Common

Sent a summary of the February Forum's views on the Council Cycle Strategy to the City Engineer expressing particular continued concern about cycling on pedestrian areas.

Made representation to Planning Committee on the QEQM site Sports Hall complex achieving earlier closing of the all-weather netball facility (9pm), no music on sports field, saving mature poplar trees and hedging on Furze Lane. The Planning Committee also required the University to enter into a section 278 Highway Agreement to make a contribution to Traffic Calming in Locksway Road.

Made a successful bid for Community Initiatives Funding to allow Milton Matters to continue.

Investigated traffic related problems in Hester Road.

Investigated use of Industrial premises in Rodney road.

Attended the Portsmouth South Police Community Liaison Committee.

Monitored developments on the land to the north of St James Hospital including the provision of Play Facilities.

Chased for progress on resolving the Milton Area and Fratton Park Traffic management Orders.

Residents may wish to note that BOTH these schemes are due to be heard by the Transportation Committee - 17th September 4pm - Room D Civic Offices.

I stood impatiently at the front door clutching my new bucket and spade. The shaft of the spade was coloured bright yellow, but the important part for digging, was made of metal painted shiny red and would last much longer than my old wooden one. They had to, because they cost six pence each at Woolworth's, nearly three months pocket money at a penny a week.

We were off to Hayling Island for the day. The picnic basket was packed and I was eager to be off, but the family were messing about at this and that. My brother with his home made wireless set trying to get good reception, as he called it. Lots of little batteries wired in parallel whatever that means, lined the widow cill. This was prior to accumulators, grid biases, larger dry batteries and the arrival of mains electricity. My sister had just had her 15th birthday and unfortunately had been given a manicure set. There she sat shaping, quicking, polishing, filing, anything but shake her feathers and get to the bus stop so the days outing could really start.

We eventually got away. A five minute walk to Copnor Bridge to catch the bus to Bransbury Park, I ran most of the way to the bridge just in time to see a bus departing. At least I was first in the queue. Well, I was until the family arrived. So I had to join them at the back of the queue and thought, there goes my opportunity of being first on the bus and able to sit behind the driver watching him drive. It was a blessed nuisance. But I wasn't allowed to say 'blessed' so only thought it. The queue was quite long by the time the bus arrived, and then the mad unruly surge forward to be first aboard. I had to stand clutching my bucket and spade because the seats were full, but I was at the front and able to see the driver at work with gear changing and steering. The conductor rang the bell and the bus, being so full, struggled slowly over the bridge and then accelerated down the other side into Milton Road, leaning over so much it frightened me, I thought we were going right over on our side. The bus recovered itself as it straightened its course, then everything in the cab seemed to rattle and vibrate, we were going so fast, the speedometer needle wobbled over the twenty mark. Because the bus was so full, we didn't stop until reaching Bransbury Park. The journey had been so quick that the conductor hadn't had time to collect all the fares on the journey, so he stood on the platform collecting them as we got off. Since nearly everyone was getting off....another 'blessed' delay, I thought.

Just around the corner in Bransbury Road stood a line of horse and traps to transport us to the ferry boat. I loved that ride. The open air. The horsey smell. The clip clop of the horse's hooves. The swishing tail. The driver in his bowler hat, whip in one hand the reins in the other. There were two steps that unfolded out of the little back door to the trap, to assist passengers entering. There was just enough room for the family of six and the driver. It was almost over before it began, and soon we were trotting between the sand dunes on the approach to the little jetty where we were to board the ferry.

I was fascinated by the collection of houseboats secured on stilts so they couldn't float away at high tides. The people who lived in them seemed very poor. But they looked happy even if they were untidy and not too clean. I thought it was wonderful to be able to live in a boat right on the edge of the shore, with the sea at your doorstep.

A Vision of Year 2000

Set in landscaped gardens and surrounded by sportsfields, a group of luxurious villas cluster round the swimming pool and social centre - of St James Hospital, Milton.

This is a vision of Portsmouth's psychiatric hospital in the year 2000, described in an article in the St James Journal, the hospital's magazine. The writer believes that only one type of mental illness will still need psychiatric hospital treatment in the 21st Centuary - neurosis.

But the stresses of life will have increased, and mental illness will still be a feature of society. "Much work will be done in the community to prevent neurosis, and prevent recurrence. Much can be done by rehousing, changing ocupation, and pointing out the possible causes for the breakdown", says the writer.

Life in the hospital - if it is still called a hospital - will be a positive encouragement to return to full health. A much improved ratio of staff to patients will "lead the residents through a web of neurosis, and pobably continue to help when the resident returns to the community.

"This will all be possible as physical disease is reduced and the problem of mental illness becomes apparent.

It will be interesting to hear the comments of the 21st Centuary therapists on our early efforts, and to look with them into the future.

Filling The Empties - The Reply

Dear Anon

As you quite rightly say the concerns you express in your letter are shared by many owners, which is one of the reasons why there are so many empty properties both local and nationally. There has always been an element of risk with the letting of properties; fears about not being able to regain possession, worries about damage and nuisance etc.

There are two points I would like to make in response to your letter.

Firstly, the 1988 Housing Act made it much easier for owners to let property with a <u>guaranteed</u> right to repossession. By creating an Assured Shorthold tenancy for a minimum of six months at a time a landlord can ensure that he/she can regain possession of the property in a reasonably short time if unhappy with the tenant after an initial six months tenancy.

Secondly, inevitably there are going to be some people who do not look after their rented accommodation. There are no guarantees with anyone, whether they are claiming benefits or not! However, to alleviate this worry housing associations now offer a leasing scheme where they take on the responsibility of ensuring the property is taken care of if the tenant causes any damage at no cost to the owner. In addition, the housing association will deal with any management difficulties including nuisance or noise problems. If these problems cannot be resolved the housing association will take action to evict the tenant if necessary and will do this at their own expense - all the while continuing to pay rent to the owner!

Leaving property empty for whatever reason not only cost owners money but is also a huge risk, with the possibility of attracting squatters and vandalism. This is also one of the reasons why it is so expensive to keep an empty property insured.

I am sure you will agree the housing association leasing scheme is a positive way of bringing empties back into use while providing total security for worried owners like yourself. If you require any further information about the Empty Property Campaign, please contact me on (01705) 834154

Summary Of Forum Meeting 7th February 1996

Opening the meeting Vice Chairperson Janice Burkinshaw welcomed members and guest speakers Mr C Stunnell - City Engineers, Mr C Monk - Portsmouth University and P.C. Walker - Hampshire Constabulary.

1. Progress Report from last Forum

Despite efforts Chair regretted no progress with the provision of play space in the Moorings Way area. The matter has been referred to the relevant councillors and council officers.

Traffic issues were updated and are being addressed by the City Engineer. New safety barriers

Traffic issues were updated and are being addressed by the City Engineer. New safety barriers have been installed at exits to Bransbury Park.

The proposed expansion of student accommodation at the Milton (QEQM) site has occupied much committee time and effort which was reported in Issue 2 of Milton Matters.

Proposals by Portsmouth City Council for the installation and management of CCTV cameras in sensitive areas was explained.

2. Changes to Forum Constitution

Mr David Pointon - Lead Officer explained the history of the Constitution and the periodic amendments needed for "fine Tuning". It requires care to ensure broad representation on the Forum but the committee must be able to respond rapidly to threatening situations before reporting back to the Forum.

It is vital that the Forum remains non political and this equally applies to correspondence in Milton Matters.

Members were taken line by line through the revised constitution and invited to comment.

Key points include:

- 2.1 Committee members minimum 10, maximum 20
- 2.2 Quorum 6 committee members and fully minuted
- 2.3 Term 'Street Representative' changed to Forum Representative
- 2.4 Revised rules for attendance at meetings by committee members
- 2.5 Guidelines for Forum members wishing to raise agenda items

The revised Constitution was accepted unanimously.

3. Election of Officers

- Chairperson Janice Burkinshaw was nominated and voted in unanimously.
- 3.2 Vice Chairperson Ken Rowlands and John Couch were nominated. Ken Rowlands was elected.
- 3.3 Forum Representatives a block nomination was presented and voted in unanimously.

4. Portsmouth City Council Cycle Strategy

Mr Stunnell began his presentation by referring back to the proposed traffic calming measures for Milton North.

The Traffic and Transportation Committee have approved the installation of road humps in Euston Road and Mariners Walk.

The Order No 36 of 1995 would be held in abeyance pending further public consultation on Item 3c.

The main concern was whether Mayles Road would be split into opposing one way systems or remain two way with calming humps.

There followed a brief mention of the proposed Tramway System.

Cycles - Portsmouth City Council wishes to encourage the use of cycles at the expense of Motor vehicles. Reduction of the latter would also help to reduce pollution, surveys showed the majority in favour of reduced car usage (50% of journeys less than 2 miles) but cycle usage in Portsmouth was low at 4% compared with other cities at 17 - 20%.

A draft (city wide) cycle network plan was displayed. Some progress has been made but provision of safe routes for cyclists are expensive to produce and slowed progress of the plan. One answer was for some sharing of pavements with pedestrians but this caused much concern and required careful consideration.

Referring to the Milton Area, the new traffic lights at the White House are integral with the Canal tow path part of the plan while a route across Bransbury Park to Eastney is in the proposal. A question from the floor suggested that road calming humps were a particular hazard for cyclists and asked if the construction of the humps could provide a path for cyclists.

5. University Of Portsmouth

Mr Colin Monk said that the Langstone Campus needed development to help provide a Hall of residence for every 1st year student to make Portsmouth University competitive. Numbers of students in Halls of Residence will increase from 1200 to 2500.

Lack of funding for repair or demolition of Barnard Tower means it will remain closed.

Mr Monk went on to explain plans for refurbishment of the campus sports facilities and hopes to be able to share them with local schools.

In answering questions he did not anticipate excessive traffic generation and stressed the plans were mainly to refurbish existing sites rather than develop new ones. Subject to University approval usage by the local community and schools would be as wide as possible. Spectator participation would come later and involve no more than 55-70 people.

Any Other Business

Some residents had written to the Ombudsman objecting to the Stage 3 hostel (St Petroc's) at the end of Locksway Rd. Cllr Mavis Southwell said that the Ombudsman supported the City Planning Committee in their deliberations.

I like the seafront because there is a pier to play games. There are also museums. I like to walk along the seafront.


I like Fratton Park because I support Pompey and I can go to their games,
